

### Social Drivers of Infant Mortality (SDOIM) Advisory Group

The Health Policy Institute of Ohio is continuing work on the **Social Drivers of Infant Mortality**. The initial report was released in 2017, and now that the 5 year anniversary is quickly approaching, we are producing:

- An **updated report** that includes information about which policy recommendations from 2017 have been implemented, barriers to implementation, and a core set of prioritized recommendations for state and local policymakers
- Series of 5 action guides highlighting the prioritized recommendations related to housing, transportation, education, employment, and racism; a description of the policy landscape related to each topic; and tools for action that will provide stakeholders with guidance on how to further implementation of the policy recommendations





### Prioritized policy goals: Housing

Goal 1: Increase availability of rental assistance

Goal 2: Reduce structural barriers to affordable housing

Goal 3: Increase affordable housing supply

#### Goal 1: Increase availability of rental assistance

Increase funding for programs that assist pregnant women and families, including those with extremely low incomes, with maintaining their current housing or affording new housing

#### State recommendations

- 1.1. Rapid re-housing and rental assistance
- 1.2. Financial incentives for prioritizing pregnant women

# Goal 2: Reduce structural barriers to affordable housing

Implement policies to protect renters from discrimination, particularly for families at highest risk of eviction and housing instability.

#### State recommendation

 2.1. Eviction expungement and other clean slate policies.

#### Local recommendations

- 2.2. Renter protections
- 2.3. Mitigation funds

#### Goal 3: Increase affordable housing supply

Increase funding for affordable housing developments for very low-income and extremely low-income renters and homeowners in high opportunity and low poverty rate areas.

#### State recommendation

• 3.1. Financial incentives for local housing development

#### Local recommendations

- 3.2. Inclusionary zoning
- 3.3. Funding for affordable housing development

Goal 4: Improve Medicaid Non-Emergency Medical Transportation

Goal 5: Improve and expand local public transportation

# Goal 4: Improve Medicaid Non-Emergency Medical Transportation

Monitor and continuously improve the performance of Non-Emergency Medical Transportation (NEMT) provided through Medicaid managed care plans, prioritizing timely services for pregnant women and parents of young children.

#### State recommendations

- 4.1. Medicaid oversight
- 4.2. Medicaid transparency
- 4.3. Managed care plan quality improvement

# Goal 5: Improve and expand local public transportation

Strengthen Ohio's public transportation infrastructure through increased investment and expanded transit services in communities most at risk for poor family health outcomes.

#### State recommendations

- 5.1. Transit funding allocation
- 5.2. Transit revenue source

#### Local recommendations

- 5.3. Transit service improvements
- 5.4. Community engagement in transportation planning



### Prioritized policy goals: Education

Goal 6: Strengthen early childhood education and family support programs

Goal 7: Reduce barriers to career-technical education and other postsecondary education programs

# Goal 6: Strengthen early childhood education and family support programs

Increase the number of children participating in high-quality early childhood education and provide support to families with young children.

#### State recommendations

- 6.1. Increase the number of early childhood care and education professionals
- 6.2. Improve supports for early childhood education startups

#### State and local recommendations

- 6.3. Increase parent education and support
- 6.4. Increase parent engagement
- 6.5. Improve early childhood education quality

# **Goal 7:** Reduce barriers to career-technical education and other postsecondary education programs

Increase funding and flexibility for career-technical education (CTE) and postsecondary education programs to increase access for secondary school students, especially vulnerable student populations.

#### State recommendations

- 7.1. Increase funding for CTE
- 7.2. Increase the number of CTE instructors
- 7.3. Remove financial barriers for postsecondary ed
- 7.4. Ensure postsecondary financial aid opportunities are available to older students returning to school

#### Local recommendation

7.4. Expand existing CTE programs



### Prioritized policy goals: Employment

Goal 8: Increase access to work supports

Goal 9: Adopt more robust leave policies and employment benefits

#### Goal 8: Increase access to work supports

Structure public benefits to help working caregivers with young children advance in their careers and reach self-sufficiency.

#### State recommendations

- 8.1. Increase eligibility for childcare subsidies
- 8.2. Reduce benefits cliffs
- 8.3. Incentivize employer child care supports

# Goal 9: Adopt more robust leave policies and employment benefits

Strengthen public and private workplace policies and benefits to provide more flexibility and support for pregnant women and families with young children.

#### State and local recommendations

- 9.1. Incentivize employer benefits
- 9.2. Increase paid family leave
- 9.3. Set living wage standard
- 9.4. Increase breastfeeding supports










# Potential goal 10: Acknowledge the effects of racism on infant mortality

Facilitate conversations about how racism has impacted birth outcomes for Black babies to open the door for creative, collaborative solutions.

- 10.1. Announce a commitment to equity
- 10.2. Share data and research

# Potential goal 11: Create and implement equitable policy agendas and plans that increase opportunities for healthy births

Enact plans that advance evidence-informed action steps to improve community conditions and increase opportunities for healthy births in Black communities.

- 11.1. Advance the **Plan of Action to Advance Equity**
- 11.2. Implement the State Health Improvement Plan

# Potential goal 12: Advocate for and fund policies and programs that promote justice and fairness

Establish policies and contribute resources to dismantle racism and increase opportunities for healthy births.

- 12.1. Advocate for policy change
- 12.2. Assess the impact of proposed policies
- 12.3. Fund initiatives to eliminate racism

# **Potential goal 13:** Recruit, support and train leaders and staff to serve communities of color more effectively

Ensure that the leadership and staff of government offices, businesses and community organizations, particularly those in the housing, transportation, education and employment sectors, reflect the communities that they serve and that all staff are trained to address racism through their work.

- 13.1. Recruit diverse staff
- 13.2. Education and train staff

# Potential goal 14: Authentically partner with Ohioans of color and tailor policies and programs to meet their needs

Establish trust with members of Black communities across the state, share power and decision-making authority and customize policies and programs to ensure they meet the needs of Black Ohioans.

- 14.1. Build trust
- 14.2. Host accessible community meetings

## Ways to influence policy

- Write letters, emails or make phone calls
- Provide district specific data
- Provide analysis of a bill
- Provide testimony at a legislative hearing
- Provide a one-page fact sheet
- Organize community partners to visit key policymakers
- Invite policymakers to visits your organization or speak at a meeting you host
