## HPIO assists in providing accurate, timely information on ACA enrollment

In an effort to ensure effective coordination of consumer education and assistance related to new coverage options in the ACA, Philanthropy Ohio has contracted with the Health Policy Institute of Ohio to manage the Ohio Network for Health Coverage and Enrollment, or ONCE.

The purpose of ONCE is to ensure that outreach, education and enrollment efforts in Ohio are coordinated and effective so that uninsured Ohioans understand and enroll in health care coverage. To achieve this, ONCE engages in strategic partnerships and provides guidance, advice and leadership for collaborative Ohio efforts.

Since its formation last summer, ONCE has grown to include more than 350 participants. Active participation by state and federal partners ensures

timely, accurate information is disseminated through the network.

According to the ONCE strategic plan, "Given that Ohio did not apply for federal funding to enhance consumer assistance programs, multiple organizations recognized the need to have a cohesive network of engaged organizations ... A broad stakeholder network serves not only in the capacity of delivering consistent information, but also can operate in a unified capacity to bring a collective voice in an advisory role."

In addition to its contracted role managing ONCE, HPIO also is convening the ONCE policy workgroup as part of the Institute's core work related to improving access to care for all Ohioans.

While much attention has been focused on federal efforts to transform the health care system, it is becoming increasingly clear that state policymakers have an opportunity to play a significant role in efforts to lower the growth rate of healthcare costs. According to the State Health Care Cost Containment Commission, "the states are in a strong position to achieve meaningful reforms and create the needed incentives with the support of payers, providers, insurers, and consumers. As the nation's "laboratories of democracy," states can serve as a proving ground for new approaches that raise the efficiency and value of health care."
