The mental health of Ohioans is trending in the wrong direction. While gaps in access to treatment remain a critical challenge, data from the Health Value Dashboard also points to broader drivers, including limited social connection and economic instability.

This breakout session will explore various drivers of poor mental health in Ohio and elevate ways in which communities can support mental health upstream. Speakers will discuss how communities can strengthen the conditions that support mental well-being, such as fostering social connection, improving economic stability, and building supportive environments, alongside efforts to expand mental healthcare access.

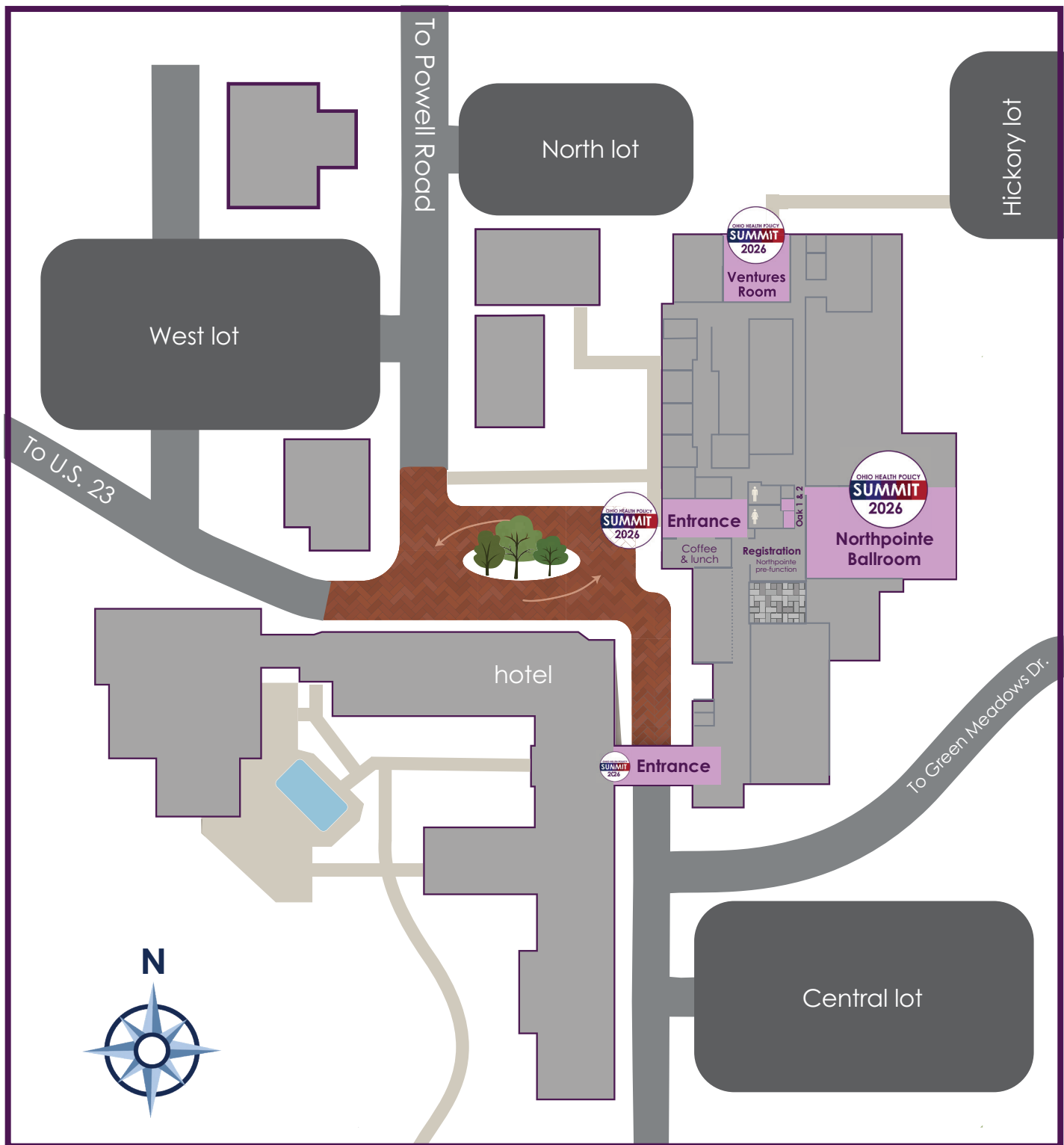
