We also work with LCADA and are funding work to identify strategies to work with Hispanic/Latinx communities. Too many times, systems just translate work from English to Spanish, but we want to identify and understand cultural barriers and opportunities that we can better serve the Hispanic/Latinx population. We also have worked with the refugee communities in Ohio to better understand and work with stigma in the multiple refugee communities in the State. In the spring, we will be hosting webinars with the Asian-American and Pacific Islander community to better work with stigma in those communities. I hope this helps!
