### Speaker biographies

### J. Nwando Olayiwola, MD, MPH, FAAFP

Chief Health Equity Officer and Senior Vice President, Health Equity and Social Impact, Humana Inc.; Adjunct Professor, The Ohio State University College of Medicine, Department of Family and Community Medicine, and The Ohio State University College of Public Health

Dr. Olayiwola is one of the nation's preeminent physician executive leaders in health equity, health systems redesign and primary care-public health leadership. Raised in Columbus, Dr. Olayiwola has had an impressive career as an internationally renowned Board-certified family physician, public health professional, health systems and primary care transformation leader, workforce diversity and inclusion champion, health technology pioneer and published author of four books.

Dr. Olayiwola is the inaugural Chief Health Equity Officer and SVP for Humana, Inc., leading health equity related efforts and population health initiatives for millions of members across the nation. In this role, she led the creation of an ambitious health equity strategy and her team is implementing multiple product, workforce, clinical and community health innovations and programs tackling health disparities and social needs for populations that have been marginalized or made vulnerable. She also currently serves as an adjunct professor at The Ohio State University College of Medicine and College of Public Health, a community leader in New Albany, Ohio and a practicing family physician at Heart of Ohio Community Health Center, serving a largely medically underserved patient population.

Until 2021, Dr. Olayiwola served as the Professor and Chair of the Department of Family and Community Medicine and Chief of Family Health Services at The Ohio State University, where she also founded the Center for Primary Care Innovation and Transformation and was the Chancellor appointed Co-Chair of the Anti-Racism/Health Equity Action Plan for the entire medical center and OSU's seven health sciences colleges. Dr. Olayiwola was a Commonwealth Fund/Harvard University Fellow in Minority Health Policy at Harvard Medical School and received her master's degree in public health with a concentration in health policy from the Harvard School of Public Health. She obtained her undergraduate degree in Human Nutrition/ Pre-Medicine at the Ohio State University, Summa Cum Laude and with Distinction, and her medical

degree from the Ohio State University/Cleveland Clinic Foundation. She completed her residency training in family medicine at Columbia University/New York Presbyterian Hospital, where she was a Chief Resident. She is a proud member of Alpha Kappa Alpha Sorority, Inc.

### Amy Bush Stevens, MSW, MPH Vice President of Research and Evaluation, HPIO

Amy Bush Stevens is the Vice President of Research and Evaluation at the Health Policy Institute of Ohio. Stevens leads policy research and evaluation projects related to population health, public health and prevention, mental health and addiction, equity and the social drivers of health. She also serves as HPIO's evaluation coordinator.

Prior to joining HPIO, Stevens served as the Program Evaluator at the Community Mental Health and Recovery Board of Licking and Knox counties and as a program evaluation trainer and coach with local prevention coalitions through the Ohio Domestic Violence Network. Stevens began her research and evaluation career at Wilder Research Center in Minnesota, and at the Institute for Policy Research at Northwestern University. She holds master's degrees in public health and social work from the University of Minnesota and a bachelor's degree in Religion from Kenyon College.

#### Carrie Almasi, MPA

#### Director of Assessment and Planning, HPIO

Carrie Almasi is the Director of Assessment and Planning at the Health Policy Institute of Ohio. Almasi oversees HPIO's Assessment and Planning stream of work, which includes needs assessments and strategic plans produced for decision makers at the state and local level. She leads projects on issues such as health equity, population health, healthcare spending and the social drivers of health, and has expertise in policy areas including child and family health, health disparities and inequities, older adult health and COVID-19.

Prior to joining HPIO in 2020, Carrie was Assistant Vice President of Community Impact at United Way of Central Ohio. She also previously led central Ohio's free tax preparation coalition and served two terms as an AmeriCorps member. Carrie holds a master's of public administration from Ohio State University and a bachelor of arts in international studies from Miami University.

### January Angeles, MPP

### Managing Director, Bailit Health Purchasing, LLC

January has over 20 years of experience in health care policy and management. Her expertise includes legislative and policy analysis, program development and implementation, and program management and evaluation, with an emphasis on publicly financed health care.

January's current work focuses on helping states establish health care cost growth target programs, working with Connecticut and Washington on developing the target methodology, and assessing performance against the target. She also works with states to leverage procurement and contract oversight processes to strengthen their Medicaid managed care programs.

Prior to joining Bailit Health, January served as Deputy Medicaid Director for Managed Care and Oversight and as CHIP Director for Rhode Island. She led cross-functional teams responsible for managed care contracting, delivery system reform, policy and regulatory compliance, data analytics, and program integrity. Before working for the State of Rhode Island, January was a Senior Policy Analyst at the Center on Budget and Policy Priorities, where she worked on Affordable Care Act legislation and implementation, with a focus on expanding Medicaid, implementing the premium tax credits and coordinating eligibility for health and human services programs. January's other health policy experience includes working at the Center for Health Care Strategies, American Institutes for Research and Mathematica Policy Research.

January earned a bachelor of arts degree in psychology from Oberlin College, and a master's of public policy degree from the University of California, Berkeley, Goldman School of Public Policy.

### Lori Criss, MSW

### Director, Ohio Department of Mental Health and Addiction Services

Lori Criss has served in various executive leadership and policy-making roles in Ohio's behavioral health field for more than three decades. Criss was appointed Director of the Ohio Department of Mental Health and Addiction Services by Ohio Governor Mike DeWine in 2018. As Director of a cabinet-level state agency, Criss has focused on growing and modernizing person-centered behavioral health prevention, treatment, harm reduction and recovery supports; erasing the stigma that surrounds substance use disorders and

mental illness; developing a strong and supported workforce; enhancing the use of data to improve outcomes; promoting parity; and focusing on populations that have experienced inequity in access to services, quality in care and outcomes.

Before joining the State of Ohio, Criss served as the Chief Executive Officer of the Ohio Council of Behavioral Health & Family Services Providers, and worked for the Ohio Commission on Minority Health and Amethyst, Inc. She holds bachelor's and master's degrees in social work from Ohio State University. She graduated from SAMHSA's 2010-2011 Women's Addiction Services Leadership Institute, a year-long nationally selective, intensive program designed to build leaders for the nation's behavioral health field.

### Kristopher Vilamaa

Kris has over 19 years of behavioral health, health information technology and health policy experience. Kris has led major state system transformations including planning for Medicaid Transformation, development of new behavioral health treatment standards, service definitions and leading large information technology system. implementations. He has worked with state and county health departments, managed care organizations, community mental health providers, county behavioral health boards, federally qualified health centers, safety net hospitals and large health systems to enact meaningful initiatives. Prior to joining HCP, he was Director of Behavioral Health for Germane Solutions and the first Chief Information Officer for the Alabama Department of Mental Health. He earned a bachelor of arts in political science from Purdue University in West Lafayette, Indiana.

Anna Novais, DMD, is the Dental Director at the Cincinnati Health Department, where she oversees the operation of 11 dental centers and also provides comprehensive oral care to patients at school-based and community health centers.

Dr. Novais obtained her dental degree from Rutgers School of Dental Medicine where she was the recipient of the Humanism Scholar Award. She completed her residency training in general and hospital dentistry at the Miami Valley Hospital in Dayton, Ohio.

President and Chief Executive Officer, Birthing Beautiful Communities

Jazmin Long is the President and Chief Executive Officer of Birthing Beautiful Communities, a nonprofit dedicated to transforming lives and reducing Black mortality by matching women with a doula and a perinatal support team member from their neighborhood at no cost.

In addition to her extensive perinatal experience, Jazmin serves as a board member of many community organizations, including Near West Theatre, The Cleveland Police Foundation, and Assembly for Action.

A native of Connecticut, Jazmin is a graduate of Connecticut College, where she earned a bachelor of arts in government. She is also a graduate of Case Western Reserve University's Mandel School of Applied Social Sciences where she earned two degrees, master of science in social administration and master of nonprofit management.

### Kate Sommerfeld, MPA

President, ProMedica Social Determinants of Health Institute, Corporate Vice President, Community Relations and Social Investment, ProMedica

Kate Sommerfeld is the president of the Social Determinants of Health Institute for ProMedica, a mission-driven, not-for-profit, health care system based in Toledo, Ohio. Kate is responsible for shaping and leading ProMedica's work on Social Determinants of Health, including clinical integration, medical education and training, strategic community initiatives, community partnerships and corporate giving.

Prior to joining ProMedica, Kate worked for various community-based and nonprofit organizations including in the United Way system leading both

rural and urban change. Kate has bachelor of arts degrees in political science and child psychology from Purdue University and a Master of Public Administration degree from Bowling Green State University.

### Lydia Dippre, CCHW, MLS

Health Equity and Outreach Program Director, Hocking Athens Perry Community Action

Lydia Dippre serves as the Health Equity and Outreach Programs Director at the Southeast Ohio Foodbank — a program of Hocking Athens Perry Community Action (HAPCAP).

She is a licensed Community Health Worker through the Ohio Board of Nursing and holds a master of legal studies degree from the University of Oklahoma.

With five years of serving neighbors at HAPCAP, Lydia has extensive experience working with vulnerable, underserved and under-resourced populations. She started the HAPCAP for Health program in late 2020 and currently oversees its suite of programs including Bringing Healthy Home, FoodRx Pickup and Delivery, Medicaid Connect and the SNAP Outreach program. Since entering the health equity space, Lydia has broken down barriers for rural Appalachia in pursuit of better health outcomes and food security for the Southeast Ohio region by developing and implementing a variety of evidence-driven pilots in partnership with key stakeholders including managed care organizations, healthcare systems and other community-based organizations.

Shelly Douglas is the Executive Director of Green Columbus, a volunteer-driven nonprofit seeking to improve equitable environmental outcomes for the people of Central Ohio. She earned a bachelor of science degree from Ohio State University.
